## MEMBERSHIP OPPORTUNITIES

The **Lake Charles Racquet Club** is a member owned Private Club since 1973. The Club is situated on a 9-acre wooded site along scenic Contraband Bayou. The Club promotes and encourages an interest in the game of tennis along with a variety of social activities.

The Club offers Eight lighted hard tennis courts and 4 lighted Clay courts totaling 12; a top-of-the-line 25-yard swimming pool; fitness center; locker room facilities; and an upstairs clubhouse with scenic views of the pool, bayou and tennis courts. The clubhouse and pool are both available for private parties.

Social events throughout the year include, but are not limited to: Crawfish Boil, Steak Dinner, Trivia Night, Bingo, Hawaiian Luau, and Annual Christmas Party. Several tournaments are held every year which include: Tailgator, Junior L7, Calcutta and the ever-popular Contraband Days Tennis Tournament.

Lake Charles Racquet Club provides two membership categories:

**Full Membership** provides full access to all of the club's facilities including: tennis, fitness center, clubhouse, swimming pool and social activities. Full membership includes one share of stock (\$100.00 refundable value) which allows the right to vote and serve on the Board of Directors.

Initiation Fee: \$750 (plus tax) \$830.62  
Stock Fee: \$100  
Monthly Dues: \$191.00(plus tax) \$210.48

**Associate Membership** is available to those between the ages of twenty-one (21) and thirty-four (34), inclusive. Associate membership provides full access to all of the club's facilities including: tennis, fitness center, clubhouse, swimming pool and social activities.

Initiation Fee: \$250 (plus tax) \$276.87  
Family Monthly Dues: \$174.00 (plus tax) \$191.75  
Single Monthly Dues \$161.00 (plus tax) \$177.42

**Associate Family membership** is available to those who are married and those who are unmarried with dependent children.

**Associate Single membership** is available to those who are unmarried without dependent children.

Upon reaching the age of thirty-five (35), the Associate Member must purchase one share of treasury stock at the price established by the Bylaws in effect at the time the member reaches the age of 35 in order to maintain their membership and convert to Full Membership.

**Provisional Membership** is available to those on the waiting list for membership. This membership has the restriction of no tennis court play from 5pm-7pm Monday-Thursday and No clay court play before 11am Monday-Thursday! When a Full, Associate, or Senior membership is available provisional members will move from provisional and buy Stock \$100 and at this time you will have full privileges to the club.

New members must sign the agreement for pre-authorized payments (bank draft). Member account balances are bank drafted between the 10<sup>th</sup> and 15<sup>th</sup> of each month.
